II. Governing Council Business

A. Proposed Operational Budget FY 2021-2022*

Jennifer went over the FY22 Proposed Operational Budget, which included the 1.5% mandated salary increases, with the Board. She talked about the ELTP program and the differentiated contracts for teachers. Educational retirement went up from 14% to 15% on the employer side. Health and medical premiums also went up, which will affect employee and employer.

Motion by Aaron Redd to APPROVE the Proposed Operational Budget for the 2021-2022 school year.

B. Part-Time Employee Resolution SY 2021-2022*

Jonas explained to the Board this is to provide insurance to part-time employees. We do not utilize this often but this year we would have. This is a good incentive to offer employees if we need them. Next year we may need to hire a part time employee in our Special Education department. The Board discussed and agreed it was a worthwhile tool to have in case we needed it.

Motion by Marvin Larsen to APPROVE the part-time employee resolution that would cover insurance for those people between 15 and 20 hours.

IV. SPLC Administrative Update

A. School Calendar SY 2021-2022*

Jonas explained the school calendar will look different this year because we have an additional ten days on it. The start date for staff will be August 2, with students returning on August 11. We will hold parent conference via Zoom, and are working with the registrar to seamline the paperwork process so it can be delivered electronically. We will have less PD days in August but that will leave more days throughout the year. Staff is required to have 80 PD hours. Most teachers have already picked PD, some during the summer. End of year will be May 27th for teachers and students.

B. Teacher Salary Schedule SY 2021-2022*

Jennifer went over the Teacher Salary Schedule for FY 2021-2022, which includes the 1.5% increase. Aaron asked if our salary schedule was competitive with APS. Jennifer explained we are slightly higher, but not by much as 90% of our Operational Budget is spent on teacher salary. She also reminded the Board insurance rates went up, so we want to give our teachers raises but not drown the school.

Motion by Aaron Redd to APPROVE the teacher salary schedule for the 2021 Seconded by James Burton Carried All in Favor
