Chris said the Finance Committee met today. He said they looked at the check register report. They went over a lot of BARs, everything is going well, and business is as usual.

- **6.** SPLC_BAR_530-000-2122-0017-I: Increase BAR to get the actuals correct. FY2021 Audit Cash Carryover
- **7.** SPLC_BAR_530-000-2122-0018-I: Increase BAR for the HB33 fund. FY2021 Audit Cash Carryover.

C. Business Office Report

Jennifer said there is not much to report this month. We have a new hire for the Afterschool Program. The transition from Maria to her is going smoothly and the school is good to go.

IV. Ongoing Governing Body Business Matters

A. Annual Training Update

Alissa asked about the conference on December 1st and 2nd. Chris said he attended, it was focused on legal issues, and he sent PowerPoints to the Board members if they would like to review it. Jonas said he will be looking at the HB 43 language that is due to the PED by January 28, 2022. This will be put on the January Board meeting agenda to discuss with the Board and ask for approval.

B. Board Retreat

Alissa discussed a retreat with the Board. She would have liked to have it in December, but everyone is too busy. They discussed having a retreat late January, possibly the 29th. Jonas discussed what the retreat may look like, including getting to know each other, basic strategic planning, looking at the direction the school wants to move forward with, and putting together an action list. This will allow for continuous improvement.

V. SPLC Administrative Reports

A. Head Administrative Report

Finance - Jonas explained some BARs are to move money around for stipends for staff to run clubs after school. There have been requests by students and parents to form clubs surrounding activities such as biking, LGBTQ, Lego League, and Student Council. The teachers work hard and we need to support them with funding so they are more receptive to hosting a club. Student Council is vital for student engagement and it also acts as an advisory council to administration. He is also looking at community partners that work with the school, which could be a monthly art class by a UNM

student. We have a fundraiser through SchoolStore and they are providing extra incentives.

B. Assistant Principal

COVID – Lisa discussed the Test to Stay program. They were on-campus last week for the first round of surveillance testing, in which no parents signed up for. They did not show up this week. Lisa is working with the program to ensure they will resolve staffing problems and be on-campus regularly in January. We are going to train some staff members to do testing onsite. The PED has announced a new requirement for staff: beginning January 17, 2022, staff members will need to have received the booster shot or they will need to do weekly surveillane testing.
