A. Governing Board Training

James went over our training and what we all have completed up until now, and to continue to push through and possibly get more done during our break.

VII. Head Administrator Report

Jonas started off with our enrollment report he stated that we are up to 155 students being that the 120-day report was coming up we are continuing to take in students. We are at our max with our 4th and 5th graders, leaving some wiggle room for our older students in the 7th and 8th grade(s). Jonas then added that our 6th grade is where we are needing a majority of our enrollments and have even advertised it with only a few who had responded. Next Jonas went over our most recent staffing, we have our new 5th-grade teacher starting at the beginning of the second semester and we also got a new Special Education Coordinator who is beginning December 06th of this year. Jonas stated that he and the SPED Coordinator have been working closely to get him caught up on student files, getting put into the PS system, and situated in his new classroom. He ended with a report of a new student we are currently enrolling, this student was experiencing homelessness and having to relocate with a family member to a different home. With that, the new guardian of the child is finding difficulties retrieving time-sensitive documents to enroll him. Jonas stated that we have been working very diligently to get this student enrolled and into school due to him being out already a month and counting. But all in all, we are ending this semester on a good note.
