III. Financial Update

A. Finance Committee Report (Committee met September 15th, 2022, at 4:30 pm) DeEtte went over our numbers and reports and said we did get an insurance recovery

from the Glasrud case of \$62,000 and split the funds between the three schools. No variances were recorded in the balance sheets, so, all looks well.

B. Budget Adjustment Requests*

VI. Head Administrator Report

Jonas went over how our charter school is working together as a whole, and as the new school year has started, there has been and will continue to be changes. He informed the board that SPLC has been invited to try the new mock trial this year and it will be the first that has been offered to middle school students. SPLC is working on adding to our CBAs as far as it being educational and ties in with their classes. He goes on to say he'd like to work on having a parental advisory committee, student advisory committee and to expand the student council's ownership within the school. This will allow our charter to have communication between the parent(s), student(s), and teachers directly. Jonas is still currently trying to advertise our school through our website, and utilizing apps for better communication throughout the school day between staff. (Chris Ortiz left Zoom (a, 5:30)

VII. Vice Principal Report

Tonya started off with our monthly Covid report, we are still currently doing good and will continue to go by the CDC Protocols. With that we are still using the UV light and everyday cleaning to prevent any bacteria or germs. Tonya went on to explain the standardized tests that are required and that we are currently doing our NWEA testing. This standardized test will take place 4 times throughout the school year. Tonya added that Mrs. Mora and herself will be the hosts of the SSLC/SPLC Equity Council for this year, with their first official meeting next month, they have sent out flyers for parents and students to join. Lastly, Tonya expressed her concerns for an incident that had occurred with a student earlier that week, she went on to explain that this student was advising other students not to come to school. This led to a situation where the principal and vice principal were needed and had to bring in the parents of the student and concluded that suspending him was the best and safe option to with while the incident was under investigation. Together they went over SPLC's protocols and procedures and informed all SPLC and SSLC families.
