III. Governing Council Committee Reports

A. Finance Committee (Committee met July 20th, 2023, at 4:30 pm)

Chris Ortiz noted that the finance committee met. He mentioned that we have finished the fiscal year as of June 30, 2023. He then turned it over to Jennifer Vigil to give a summary of where we are as of June 30th. Jennifer Vigil stated that we have an ending carryover balance that is much larger than we originally anticipated. Our RfR's have been submitted to PED and our SEG for June was received timely. Jennifer and Justine are continuing to work together to get PED reports and all end of the fiscal year tasks completed in a timely manner.

1. Request for Inventory Disposal*

Jennifer went over the disposal package for a playground repair. The playground was initially purchased by SSLC, but SPLC completed a repair to the playground totaling 15K. This was then capitalized by SPLC and added as a capital asset in our system. SSLC has since disposed of the playground and therefore we are requesting this disposal as well, being that it is outdated and a liability to student safety.
