DeEtte Peterson presented that the finance committee meeting went well. The budget isn't showing teacher contracts at this time due to contracts not being entered in as of July 31. We did see some negative functions throughout the budget, but Jennifer and Justine have had a budget meeting and are getting those fixed. Jennifer will be doing a couple of maintenance BARs to ensure we are in compliance for quarterly reporting. Lastly, teachers have begun ordering their classroom supplies and those supplies are coming in timely.

B. Audit Committee

Chris Ortiz let the board know that the second audit entrance meeting took place, and we are scheduled for another meeting in September. Other than that, there is nothing new to report.

C. Strategic Planning Committee

The 4th, 5th, and 6th graders will begin testing on Monday, August 21, 2023. This will help us see where our students are and how we can improve their education.
